

# Privacy Policy

This Privacy Policy ("Policy") applies to rdtinnocencealliance.org, and Roadside Drug Test Innocence Alliance Inc. ("Company") and governs data collection and usage. ## Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us.
